Title: WARNING "You can continue your process but you have the responsibility to clarify the legal situation"


You are purchasing an Export restricted part that will require an Export licence determination from the OEM. Please contact your OEM and request that they advise you whether an export licence is required for this part giving them the A/c reg and serial number and the end user/owner/operator all this information must be clearly visible on your purchase order. If a licence is required, in most instances it will be the OEM's responsibility to obtain. Jet is responsible to retain a record of licence status (ie licence required and obtained, or NLR [no licence required]). The OEM must then send you the export licence agreement which needs to be filled out by:

1. Designated authorized person at your facility to sign on behalf of Jet Aviation.
2. Designated authorized person who can sign from the






On accepting the Confirmation, any notes as applicable will be displayed:



Note that the above Notes will also display for any P/no that has been entered in the Control file list i.e. whether they are tagged EAR,ITAR ...or blank


For items subject to ITAR, a different message is displayed:
